



**Town of Burlington trash and recycling is picked up weekly,  
Monday-Friday, beginning at 6 A.M.**

ASDA Enterprise Inc. is a manual collection company. Our drivers must lift the cans into the truck by hand. When filled, 96-gallon containers become extremely heavy and awkward, therefore cannot be lifted safely. In compliance with our Workers' Compensation Insurance requests, we will not accept 96 gallon trash containers. If you are currently using a 96-gallon container and wish to continue, all trash must be bagged. If the bag tears, the trash will be left. *See below for more details.*

## **TRASH**

ASDA does not provide trash cans. Trash cans are not required for trash collection; bagged garbage will be accepted curbside. If using a trash can, ASDA requires that the can be no larger than 48 gallons in size. You may have up to (4) 48-gallon trash cans of household waste per week, with a maximum weight of 60lbs per can.

## **RECYCLE**

ASDA provides each residential customer with (2) 18-gallon recycle bins. One of your bins is for paper and cardboard and the other bin is for your plastic, glass, aluminum, and tin. *See below for recycling specifications.*

- All cardboard boxes (flattened)
- Paper products including mail
- Clean food product boxes i.e. pizza boxes
- Aluminum, tin, and bimetals food and beverage cans
- All colored glass bottles and jars
- 1, 2, & 5 plastics excluding acute toxins or empty oil containers

\*Oil waste (cooking or motor) will be collected **IF** it is in a 1 gallon container with a screw off cap. It must be clearly labeled and placed next to your recycle bin.

**Non-recyclable items will not be collected from your container as per DNR enforcement on contamination.**

## **TIRES**

Residents in the Town of Burlington are allotted up to (8) car tires per calendar year, 1 tire per week. Car tires OFF the rim may be placed next to your recycle bin and it will be collected by your recycle driver. Car tires ON the rim and all other tires are a special pickup that need to be scheduled with our office. The pricing is as follows:

Car tire on the rim: \$10 per tire

Semi/Truck tire on & off the rim: \$65 per tire

Field tractor tire on and off rim: \$110 per tire

## **BULK-ITEM PICKUP**

Residents in the Town of Burlington are allotted up to (12) bulk-items per calendar year, 2 per week, at no additional cost. These items are collected on your regularly scheduled trash collection day (Tuesday). Ex: sofa, mattress, recliner, etc. Please call the office to schedule your pickup.

## **METAL COLLECTION**

All items 90% metal or more will be collected at no additional cost. Please be sure to empty all appliances prior to pickup. Ex: freezer, dishwasher, refrigerator, lawnmower, etc. Please call the office to schedule your pickup.

## **ADDITIONAL FEE ITEMS**

- TV's & computer monitors
- Hot Tubs
- Pianos
- Empty propane tanks

## **YARD WASTE**

Yard waste will not be accepted by ASDA. Town of Burlington residents may take yard waste and other materials to:

6120 English Settlement Road (Highway J)

March thru September - 2<sup>nd</sup> and 4<sup>th</sup> Saturdays

October thru November - every Saturday

December thru February - 2<sup>nd</sup> Saturday

Acceptable items: brush, compost (grass & leaves), concrete (clean only), rocks, scrap metal (no cement or wood attached)
